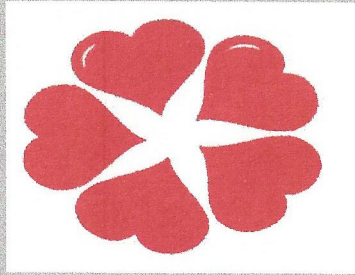

Overview

The Self-Directed program is designed to help functionally disabled Nevadans of all ages and frail elderly Nevadans. The services are provided in the consumer's home by a PCA of the consumer's choice. The services available under the Self-Directed program are designed to help with activities of daily living and include tasks such as;

- Bathing
- Dressing and grooming
- Toileting
- Eating assistance
- Light housekeeping
- Meal preparation
- Medication reminders

ELIGIBILITY REQUIREMENTS

- Enrolled in community Options Program for the elderly (COPE)
- Personal Assistance Services (PAS) program
- Medicaid eligible in Nevada
- Physical disability which the individual require hand on assistance with activities of daily living.

WHAT THE CONSUMER NEEDS TO KNOW

The consumer will be evaluated by the State of Nevada or its designee with an assessment determining eligibility of the consumer requiring hands on assistance with tasks.

Individual receiving services must be able to manage their own care or have a designated legal representative to manage their care.
